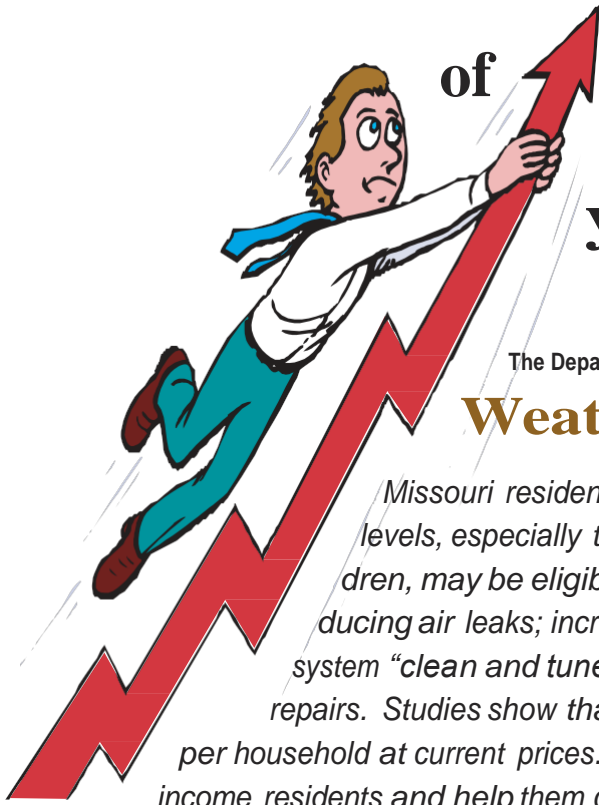


# Concerned about the **rising cost** of **heating and cooling** your **home**



The Department of Economic Development's Division of Energy administers the  
**Weatherization Assistance Program.**

*Missouri residents with incomes at or below 200 percent of the federal poverty levels, especially the elderly, the physically disadvantaged and families with children, may be eligible for assistance. Energy-efficient improvements may include: reducing air leaks; increasing insulation in the walls, attic, floor and foundation; heating system "clean and tune"; heating system replacement; and minimal building envelope repairs. Studies show that weatherization reduces average annual energy costs by \$437 per household at current prices. This can reduce the burden of high energy costs faced by low-income residents and help them catch up on overdue utility bills.*

## **The Weatherization Program creates energy-related benefits:**

- Energy savings average is 35 percent of pre-weatherization consumption.
- Weatherization annually decreases national energy consumption by the equivalent of 24.1 million barrels of oil.
- U.S. Department of Energy studies conclude that the cost-benefit ratio of direct energy reduction is \$2.71 for each dollar invested in weatherization.

## **The Weatherization Program creates non-energy benefits:**

- For participating households: increased property values.
- For individuals: money is made available for other basic necessities, medicine or groceries.
- For utility companies and ratepayers: reduced costs for bill collection and service shut-offs.
- For the local economy: energy efficiency work creates jobs.
- For national security: decreased dependence on foreign oil.
- For the environment: reduced need for combustion of fossil fuels and resulting emissions into the atmosphere.

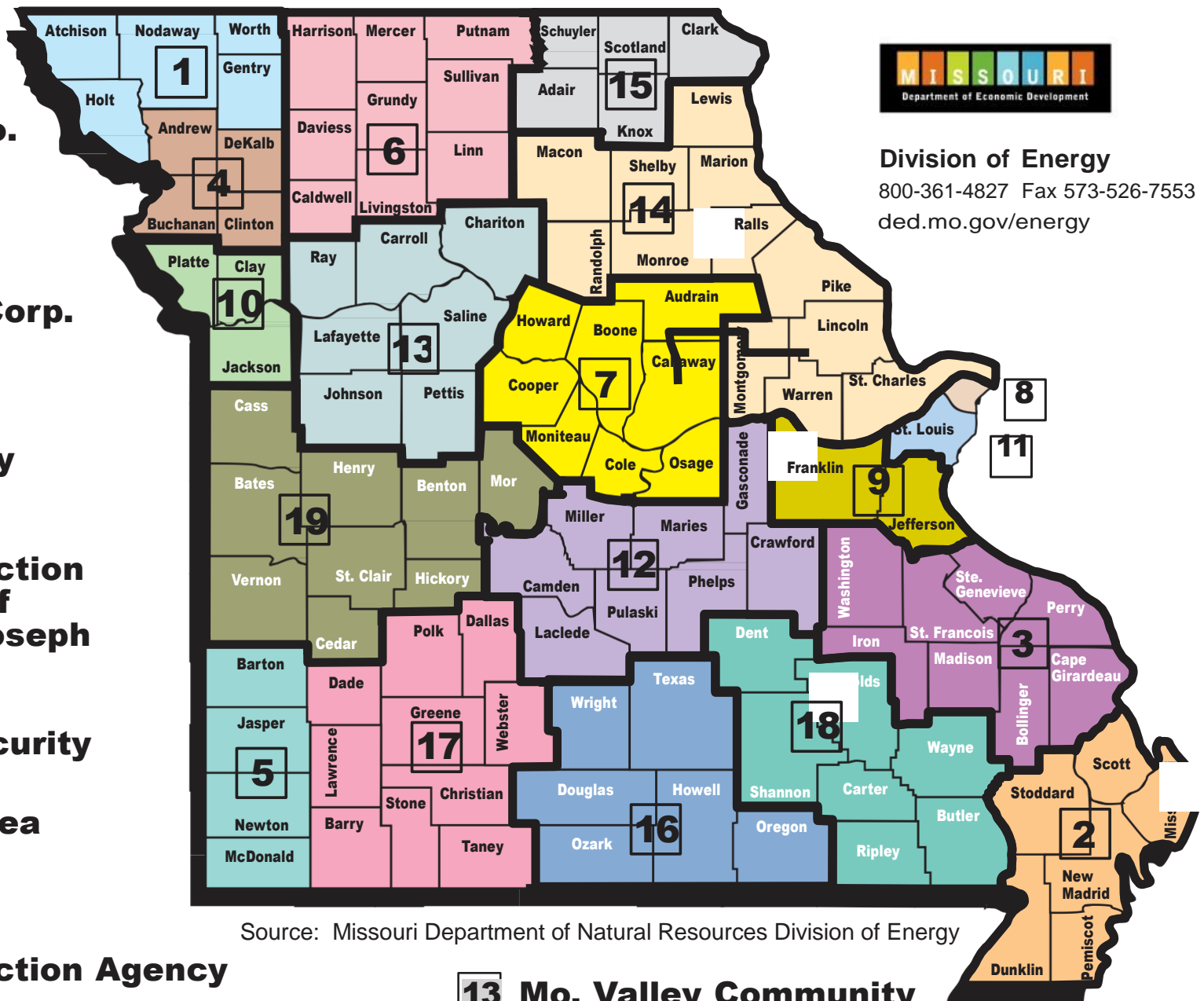
